Essential Functions

- Conducts routine patrols of campus, reports incidents and safety/security hazards
- Responds to and takes appropriate action in the event of a conflict or emergency situation
- Participates in local disaster preparedness exercises as appropriate
- Provides assistance to students, faculty, staff and the general public
- Secures and unlocks campus facilities as needed
- Performs crime prevention and awareness functions
- Perform other duties as assigned or needed

Qualifications

- At least 19 years of age with a high school diploma or equivalent and one year of security or law enforcement experience or any combination of experience and education which provides the applicant with the desired ability required to perform the job
- Valid Idaho driver's license and be insurable under campus vehicle policy
- Successfully pass a pre-employment background investigation, which could include: being of good moral character, a criminal history check, and a Psychological evaluation.

Ergonomic/ Physical Activity and Requirements:

- Physical Requirements: Ability to lift up to 30lbs.
