SR 1901
A RESOLUTION

Resolving that the time period on Tuesdays and Thursdays from 11:30a.m.-1:00p.m. throughout the school year be institutionalized as reserved only for student-led activities and faculty governance meetings and activities.

WHEREAS:

- I. This time slot has traditionally been *recognized* and *understood* as a time for students to have club meetings, and as a time *reserved* for non-class faculty meetings.
- II. There have been talks in the past of respecting this time, but there have been no attempts at institutional enforcement.
- III. This is an attempt at telling the administration that student leaders no longer want this to be only a guideline but an enforced time that is only reserved for student-led and non-class faculty meeting activities.
- IV. This time slot would be reserved for student-led clubs and organizations and other student-led initiatives.
- V. Involvement and integration of all students into the greater campus community is vital to building a successful, sustainable campus culture.
- VI. This time slot contributes to cultivating interconnected relationships among all of our students.
 - a. The College presents itself as standing for the development of the entire student; academically, athletically, and experientially.
- VII. Institutionalizing this time slot with regard to scheduled student activities for only student-led activities should be of great importance because this would fend off the encroachment of classes, sports practices, and institutional meetings into an invaluable time that should be reserved for student community building.
- VIII. The activities that require student participation that would be permitted to utilize this time slot are as follows:
 - a. Student-led meetings or other student-led activities
 - b. Registered club sport teams' practices and meetings
- IX. The required activities barred from utilizing this time slot are as follows:
 - a. Academic or student affairs classes or trainings led by faculty or staff
 - b. Academic labs or rehearsals
 - c. Coach-led athletic practices
 - d. Coach-led athletic meetings
- X. This should be of great concern to College administrators, Student Senate, and other student leaders because we, as an institution, are not currently taking full advantage of the diversity of our students because many students are inhibited from participating in clubs, because of the limitations that would be remedied by the measures indicated above.
